## **Strange Butler, Missouri Case to be presented at UFO conference in Columbia, Missouri**

UFO Researcher and MUFON Star Team Field Investigator Margie Kay has been investigating the strange case involving Richard and Lori Carter of Butler, Missouri. The Carters have been having strange experiences since September of 2009, which involve missing time, possible abduction, and encounters with unknown humans or extra-terrestrials. Rich Carter has taken numerous photographs of unknown objects while searching the roads in Bates county around Butler. Kay is working on a documentary film and book on the Carter's experiences, and will present this case for the first time at the Midwest UFO Conference August 14-15 in Columbia, Missouri.

The Missouri Mutual UFO Network, Missouri Investigator's Group, and the St. Louis UFO Study Group have coordinated the Midwest UFO Conference August 14-15, 2010 at the Day's Inn Conference Center, 1900 I-70 Drive SW, Columbia, Missouri in response to the recent wave of UFO sightings in Missouri. These groups seriously and scientifically study the UFO Phenomena.

Missouri MUFON State Director Debbie Ziegelmeyer stated that the increase in sighting reports and reports of close encounters is concerning. "We don't know why reports have increased in the last few months, but we'd really like to find some answers," said Debbie. Ziegelmeyer is the founder of the International MUFON Dive Team and a UFO investigator. She will be speaking at the conference about her Roswell crash site investigations and will conduct a seminar on how to document UFO sightings.

Other speakers include keynote speaker Chuck Zukowski, who will lecture on his Colorado Cattle Mutilation investigations. Film producer Joe Palermo will talk about his paranormal, Bigfoot, and UFO encounters; Certified Hypnotherapist Linda Eastburn will speak about her client's close encounters; Investigator Gary Hart will discuss the Strange Seymour, Missouri UFO case; and Margie Kay, author of "The Ghost Hunter's Field Guide" will conduct a workshop on remote viewing and do a lecture on the strange Butler, Missouri case.

The conference hours are Saturday 9:00 AM—5:30 PM and 7:00 PM—9:00 PM, then Sunday 9:00 AM—3:30 PM. There will be a mixer on Friday, August 13 from 6:00 PM—9:00 PM in the hotel lounge.
